The cancellations and / or modifications GROUPS are accepted up to 30 days before the date of travel and FITS until 11 days earlier.

In addressing the services of the train, all passengers must submit with its trip ticket, an original document or a photocopy of their identity. Without the submission along with the passage you can not make boarding (SUNAT Resolution 156-2003-SUNAT, Tax Code).

The luggage space in the various services is limited, the excess of these could block access doors and hallways of the various cars which is prohibited by legal provision, therefore, Perurail has the power to prevent their introduction into cars (DS 032-2005-MTC art. 128 inc.k). We ask only what is necessary to bring on board and leave your luggage stored in Cusco as can be in the warehouse of his hotel.

Subject to change due to changes in the price of admission and transfer by bus to Machu Picchu (INC and CONSETUR) respectively
